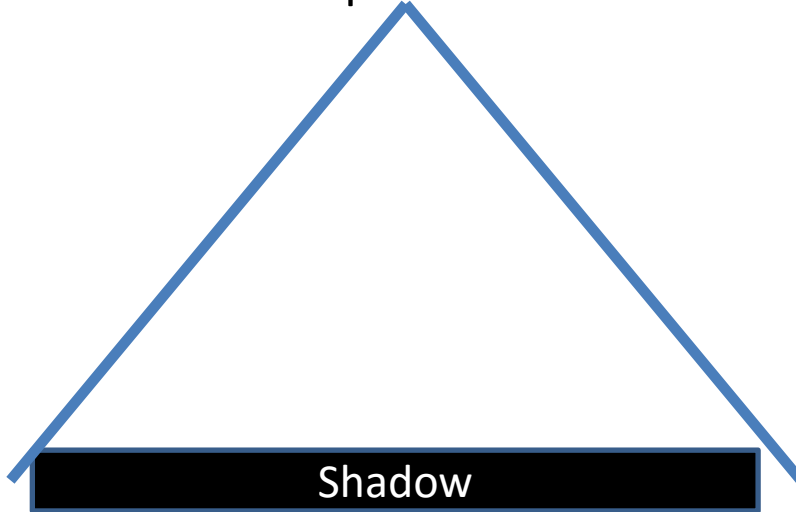

- 7 Mountains governmental spheres
- Council of 12 – overall government

- House Ekklesia or Qahal needed 10 to form around a blueprint
- Bench of 3
- Angel of the House who is the apostolic representative of the 7
- Bench of 7 priestly agreement between heaven and earth
- All operating according to 4 faces of God

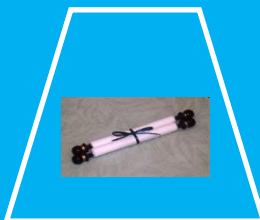

Legislative Groups

- We have a mandate and blueprint
- Establish foundational government around it
- Sometimes gives to 1 person who agrees with God and forms an arc then starts to call for heavens government
- Sometimes you have 2 in agreement as an arc and God becomes the 3rd for government
- Sometimes you have 3 in government and God forms the 4th for door to be opened

Legislative Groups

- Who can be part of a bench of 3, 7, 12?
- Anyone who God calls and who is willing to serve the blueprint that God has released.
- There would have to be the ability to engage God in the heavenly realms and the willingness to continue maturing as a lord, king and son.
- Those willing to operate in mutual submission and create a culture of honour and be open, honest and transparent.

Legislative Groups

- Those willing to release others into their destinies.
- There will be many different benches with very different blueprints and there can be different benches within blueprints.
- We have a Bench of 3, 7 and 12 and each of our 7 mountains have benches of 3.

Legislative Groups

- What experience is desirable for one on such a bench?
- God would rather have an amateur in the new than a professional in the old.
- The desire and willingness to hear God's voice and see what He is doing from a heavenly perspective is far more important than earthly experience of old leadership models.

Legislative Groups

- Experience in engaging God both within and in the heavenly realms is the key but these encounters do not have to be full blown Hollywood productions.
- Humility knowing ones identity
- Gentle heart surrendered strength and boldness, pioneer spirit

Legislative Groups

- Ability to bring a heavenly order of Melchizedek perspective
- King, Prophet (Oracle) Apostle (Legislator)
- Governmental role
- Redemptive gift rule prophet teacher may be helpful but not required

Legislative Groups

- How is a bench set in place, by a democratic vote or by a heavenly appointment and by whom?
- It depends on the situations.
- Establishing a new blueprint and forming the foundational government for it from scratch would be very different from transitioning from an old church structure.

Legislative Groups

- I have been personally involved in both set of circumstances and it usually involves either someone or a group seeking God for and receiving heavenly revelation of the blueprint or the existing leadership seeking God to clarify the vision that they may already have from a heavenly perspective and seeing it in blueprint form.

Legislative Groups

- In either case there would be a priestly kingly agreement an arc and an apostolic and prophetic agreement the order of Melchizedek in operation.
- This may not happen in a deliberate overt way but has probably been happening as God leads and directs the transition but this is probably seen in hindsight rather than forethought.

Legislative Groups

- There is no democracy in heaven but there is always unity and agreement so any bench would have to accept God's heavenly appointment by being of one heart, mind and purpose.
- A bench may be recognised on earth and commissioned by someone with heavenly chancellorship
- I have done this with Benches and I know Ian Clayton has done that with me.

Legislative Groups

- What constitutes the authority and heavenly recognition of the bench of three
- Heaven recognises alignments with heavenly blueprints and the courts of heaven and the angels and cloud of witnesses associated with blueprints recognise authority
- You only have authority within your sphere of authority

Legislative Groups

- To what extent does the judicial arm or power of the bench go?
- Authority in judicial matters is first outworked in the courts of heaven before anything is then on earth as it is in heaven.
- The authority is not over people but is foundational to support and encourage people to fulfil their destinies as living stones in relationship with each other.

Legislative Groups

- There may be some correction and guidance required but this is always done within the culture of honour helping to identify the problem to find a solution.
- The bench are primary responsible for the integrity and outworking of the blueprint and that is where the authority lies not over individual people's personal lives other than to encourage maturity and relationship with God.

Legislative Groups

- There is a judicial function settling disputes bring in wisdom and mediating settlements etc.
- This is not a heavy handed approach but again a culture of honour that looks to solve the problems not attack the people

Legislative Groups

- What are the functions of the bench of three (3) regarding those who are drawn to fellowship with the bench's influence, guidance, teaching, or leading?
- To provide foundational support and guidance in relationship to the blueprint

Legislative Groups

- To be a role model of the new order
- Discipleship by actions not words
- To release people to fulfil their destiny within the blueprint by delegated authority and empowering personal engagement with God
- No coverings or mediatorial relationships

Legislative Groups

- Does the bench function under the principle of total agreement before making decisions?
- Yes if there is no agreement then there is no unity and therefore no commanded blessing.
- We always seek agreement with God and as we submit to Him we will be in agreement with each other.
- It is about a heart of unity not looking for a position or winning an argument or making a point.

Legislative Groups

- This takes the development of trust which comes through helping each other work through the issues that will inevitably arise as we are all in the process of transformation.
- The issue of senior leadership within a bench is to me the old trying to control and influence the new.

Legislative Groups

- Anyone seeking earthly recognition or validation of themselves or their identity from being part of a bench need to be willing to recognise and work through these types of issues
- Things will come to the surface that will bring transformation
- Holiness is always the goal of transformation

Legislative Groups

- What relationship should those who cluster around the bench have with the bench?
- There is no hierarchy no separation of leaders from others we are all to be in relationship with each other as brothers and sisters.
- As we all recognise each others redemptive gifts and callings then we will be able to receive the reward from each other.

Legislative Groups

- There is no covering or mediatorial approach so we encourage everyone to hear God for themselves and this will continue to contribute to the growth and maturity of the whole.
- We are all just trying to fulfil our destinies and are all called to mature in lordship kingship and sonship.
- I believe everyone has a legislative heavenly governmental position as sons and we are all gateways of heaven on earth.

Legislative Groups

- There is always accountability within any government
- This accountability is first to God for the out working of our destiny
- We are accountable to God for the blueprints being administered
- We are accountable to each other as bench members for our roles

Legislative Groups

- Bench of 3 or Beit Din or Apostolic Council
- Provide apostolic strategic direction and government
- Engages heaven and brings apostolic blueprints
- Judicial authority to administer with righteousness and justice

Legislative Groups

- Receiving & bringing heavenly blue prints, vision and direction
- Collating and reviewing internal & external prophetic revelation) – Seeking God, encountering heaven
- What is God saying?
- Releasing that prophetic direction
- Supporting others to outwork it

Legislative Groups

- Delegating authority to others enabling them to fulfil their own personal destinies and to more easily facilitate (help and encourage) the corporate destiny of the church to be fully expressed.
- These ministries would include, Bench of 7 also those ruling from the 7 mountains when established

Legislative Groups

- Receiving & bringing heavenly blue prints, vision and direction for external ministry.
- Seeking God, encountering heaven, connecting with other local, regional & international ministries.

Legislative Groups

- Judicial authority
- Church discipline judicial issues
- Arbitration of disputes between church members
- Heavenly Court functions such as administering justice by making judgments, decrees and receiving and releasing mandates to establish the government (kingdom) of God on earth as it is in heaven through the church

Legislative Groups

- Bench of 7
- Exercising the delegated Apostolic Heavenly Authority
- Ensuring the apostolic heavenly vision given to the Church or city of refuge is out worked and developed.

Legislative Groups

- Strategically supporting the Church vision to ensure unity of hearts and minds and operating in one accord.
- Releasing revelation and ministry to each person find and fulfil their destinies

Legislative Groups

- Facilitating the development of supporting ministry from a heavenly realm perspective by gaining practical understanding of the judicial system of heavenly courts to administer righteousness from the heavenlies

Legislative Groups

- Developing new ways of administering church activity from the heavenlies such as using the keys of kingdom forgiveness, binding & loosing etc.
- Supervision and oversight of public meetings by providing the welcome, protection and direction for those meetings

Legislative Groups

- Communicating with the church regarding notices, updates, events, prayer requests etc. through public notices, emails and the website
- Communicating feedback of current prophetic, pastoral and prayer trends or issues to the Bench of 3 – health check in a short email summary of anything relevant

Legislative Groups

- Operating in heavenly authority according to the order of Melchizedek
- Coordinating any practical ministry that needs delivering through those equipped and trained in new ministry methods

Legislative Groups

- New ways of ministry - experiential
- New ways of teaching - experiential
- New ways of prayer - experiential
- New ways of interceding - experiential
- New more effective ways of kingdom administration
- New ways of partnering with the angelic realm – ministering servants

Legislative Groups

- The new ways we are looking to embrace are to enable each of us to be the person God created us to be and fulfil our destiny.
- God wants to encourage everyone to search their hearts
- To be willing to ask God who am I, what am I called to do, How can I help fulfil God's blueprint?

- Bench of 12
- Angel of the house - 7
- 1 from each mountain
- FAR
- 3 shalom ministries
- Governmental foundation

- Pioneers and forerunners have no books or maps


Legislative Groups

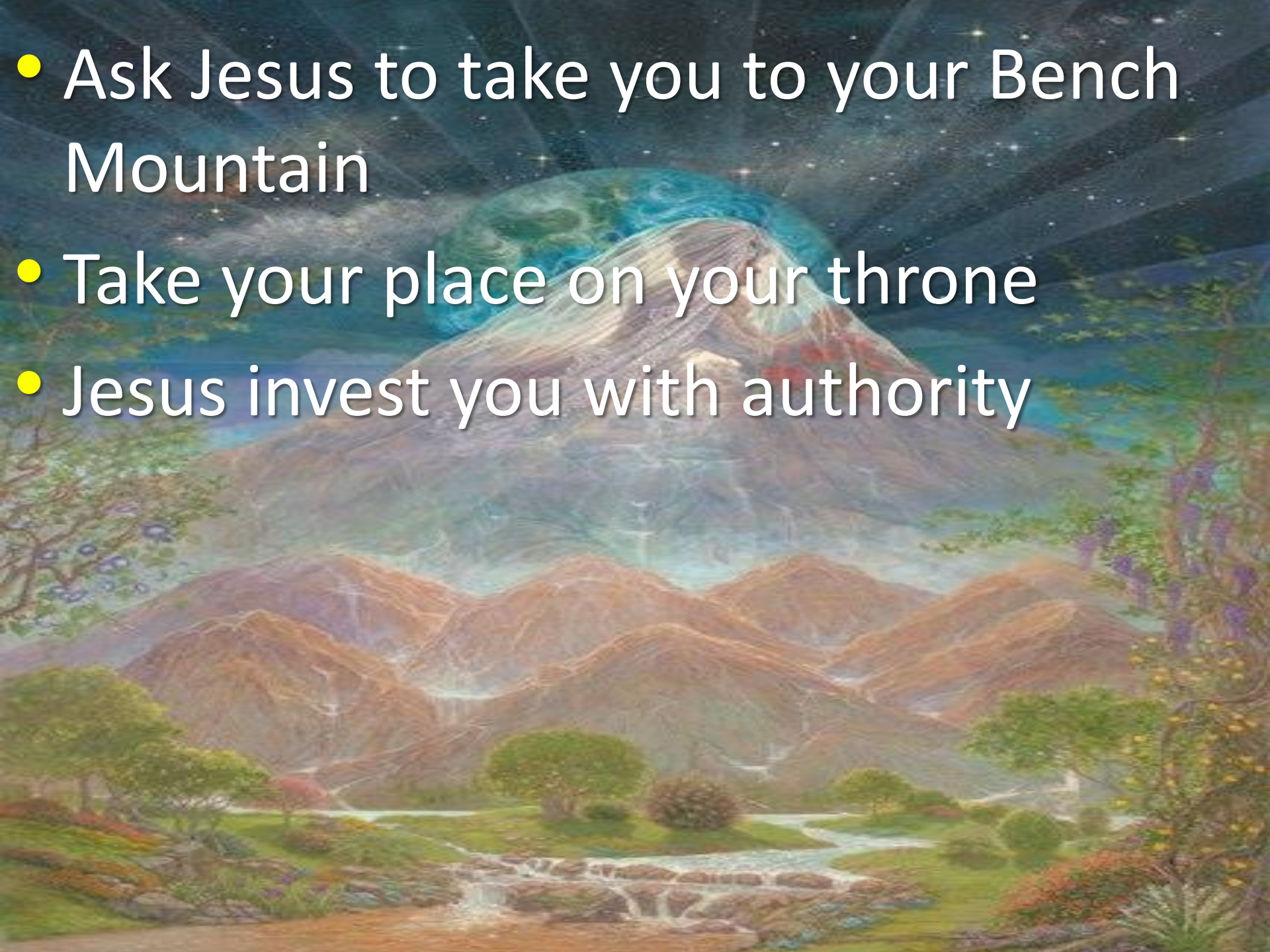
- You stand before the arc of His presence

- Receive your mandate today



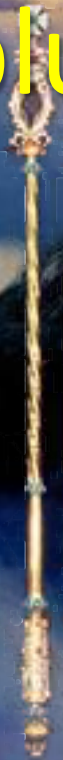
